ADS 539 – Overseas Schools Program

539.1 OVERVIEW

Effective Date: 02/11/2020

This chapter specifies policies and procedures for USAID's participation in schools identified as "dependent schools abroad". Dependent schools abroad are defined as those schools where U.S. Government dependents are enrolled.

539.2 PRIMARY RESPONSIBILITIES

Effective Date: 02/11/2020

a. The **Director, Bureau for Management, Office of Management Services (M/MS)** has delegated responsibility for administering USAID participation in the Overseas Schools Program to the Chief, Overseas Management Division (M/MS/OMD). The authority for this program is found in 2 FAM 611.7 and indicates: The Overseas Schools Program derives its authority from:

- 1) [Section 29 of the Department of State Basic Authorities Act of 1956, as amended by the Foreign Service Act of 1980;](#)
- 2) The [Foreign Assistance Act of 1961, as amended \(Sections 636\(c\) and 636\(d\)\);](#) and
- 3) The [Mutual Educational and Cultural Exchange Act of 1961, as amended \(Section 102\(b\)\(3\)\).](#)

b. The **Chief, Bureau for Management, Office of Management Services, Overseas Management Division (M/MS/OMD)**, is responsible for administering the Overseas School Program as authorized under Sections 636(c) and 636(d) of the Foreign Assistance Act (FAA) of 1961, as amended (see [Foreign Assistance Act \(FAA\) of 1961, as amended, Sections 636\(c\) and 636\(d\)](#)). The incumbent also serves as the USAID representative on the Department of State Overseas Schools Policy Committee (see [2 FAM 612.2](#)).

539.3 POLICY DIRECTIVES AND REQUIRED PROCEDURES
