The Center for Conflict and Violence Prevention (CVP) in the Bureau for Conflict Prevention and Stabilization (CPS) helps USAID Missions plan for, prevent, and mitigate the impacts of conflict and violence and promote peace through targeted technical assistance, flexible funding, and mechanisms.

### Technical Assistance:

CPS/CVP provides technical assistance at all stages in the program cycle. Types of support include: conflict assessments, analysis and data visualizations, conflict-sensitivity integration, strategic planning, and monitoring, evaluation and learning (MEL).

### Training and Mentoring:

CVP offers conflict-related courses, workshops, mentoring, and learning. In addition to our core courses of Conflict Sensitive Aid (CSAid) and Atrocity Prevention, CVP can also customize training to a Mission's needs.

### Mechanisms:

**Programming for Prevention and Peacebuilding (P4P2):** This \$800 million IDIQ assists USAID Missions/Bureaus/Offices to prevent, mitigate, manage or recover from conflict and/or violence, or to integrate conflict sensitive approaches across USAID development sectors

**Peacebuilding Evaluation, Analysis, Research, and Learning (PEARL):** This \$20 million IDIQ, with buy-in ability, provides analyses, assessments, and evaluations to Missions and advances learning in support of USAID's peacebuilding community of practice.

**New Partnerships Initiative: Conflict Prevention and Recovery Program (NPI/CPRP):** Provides USAID Missions and Field Offices with a mechanism to attract and better utilize new and non-traditional partners in countries at risk of or recovering from conflict or violence.

**Community Protection and Preparedness Program:** This program supports efforts related to violent extremism and populations affected by, or returning from, conflict and conflict-affected regions. Funding can be solicited under this Leader with Associate with the Global Community Engagement and Resilience Fund (GCERF).

**Conflict Sensitivity Integration Hub (CSIH) in Central America:** CSIH develops, tests, and delivers new approaches to conflict and violence prevention and building resilience in Honduras.

### Funding:

**Complex Crises Fund (CCF):** This \$60 million/year fund allows for response to rapidly changing, complex crises that include a combination of humanitarian, political, and security dimensions. Programs must meet an unanticipated and urgent need where a U.S. government response will help stem the rise of violent conflict and instability or advance peace and democracy.

**Women, Peace, and Security (WPS) Incentive Fund:** This \$6.5 million/year program supports women's empowerment and protection to break cycles of conflict and instability that threaten global security.

**People-to-People Reconciliation Program (P2P):** This \$25 million/year program supports Mission peacebuilding efforts that bring together conflict-affected groups to address divisions rooted in differences such as ethnicity, religion, status, gender, class, or political affiliation.
