

Presenting the Locally Led Programs Indicator

September 2024



Background

There is widespread consensus that development and humanitarian assistance must enable local actors to set their own agendas, develop solutions, and bring their capacities, leadership, and resources to bear to make those solutions a reality. Experience has shown that local leadership is critical for greater equity, effectiveness, and sustainability. USAID has embraced localization, a set of actions that shift how the Agency works to put local actors in the lead and strengthen local systems. USAID's approach to localization emphasizes shifting both resources and decision-making power to local actors.

The Goal

By 2030, at least 50% of activities

will place local communities in the lead to co-design an activity, set priorities, drive implementation, or define and measure results.



The Indicator

Percentage of USAID-funded activities

in which local partners and/or local communities lead development efforts, including priority setting, design, partnership formation, implementation, and defining and measuring results, in a given fiscal year.



Why this Indicator?

Locally led development is about more than money.

With this indicator we will:

- Learn generating information to better understand how the agency advances local leadership across the range of ways USAID engages local actors, as well as across geographies, programming areas, and funding.
- Inspire serving as an institutional reminder of our commitment to advancing local leadership in our programming





How Was the Indicator Developed?

- ~50% of Agency Programming

Why the 'Good Practice' Based Approach?

- **Broad** Recognizes the diversity of what good Locally Led Development looks like—which isn't limited to these 10 practices!
- Appreciative Builds on the great efforts that teams are already doing across the globe to elevate local leadership
- **Aspirational** Sets forth a manageable list of practices which we can aspire to utilize more
- Adaptable Allows us to add emerging new practices to aspire towards and/or shift away from tracking practices that have become the norm


