

## EVERY YEAR, USAID DELIVERS ESSENTIAL, LIFESAVING CARE FOR CHILDREN AND WOMEN

In 2023, USAID:



Helped **12 million women** to give birth in facilities receiving U.S. government support.



Resuscitated **238,000 newborns** who were not breathing at birth.



Supported **10 million newborns** with postnatal care within two days of birth.



Enabled **8.6 million infants** to receive their first dose of the measles vaccine by age one.

Reached **28 million children** under age five with nutrition programs.

Reached **II million pregnant women** with nutrition-specific interventions.

## OVER THE PAST DECADE, USAID PROGRAMS HAVE TRANSFORMED THE LANDSCAPE FOR MATERNAL AND CHILD HEALTH

Since 2012, USAID Has:



## Enabled **67.8 million women** to give birth in a health facility and helped provide care for **55.4 million newborns** immediately after birth.

Giving birth in a health facility with a skilled provider reduces risks of life-threatening complications, improving the chances of a safe delivery for both the mother and the baby.



### Provided 139.5 million treatments to children for diarrhea and pneumonia.

Diarrhea and pneumonia, while largely preventable and treatable with relatively simple interventions, are among the top killers of children under five years old.



## Trained **14.2 million health workers** in maternal and child health and nutrition.

When health workers have the expertise to provide timely and skilled care, they can prevent, detect, and manage complications during pregnancy, childbirth, and early childhood. And the provision of high-quality care leads to higher usage rates of maternal and child health services.

### Helped 29 million people gain access to basic drinking water services.

Access to clean and safe drinking water is paramount in preventing waterborne diseases, like diarrhea and cholera, which can be life-threatening for pregnant women and children.
